Applications for the post of Assistant Professors to be filled on **contract** basis on fixed remuneration were invited by MAIDS vide Advertisements dated 10.12.2018 and dated 20.12.2019. The details of applications received have been given in Annexure-I & Annexure-II. Now, it has been decided to fill all vacant post of Assistant Professors on regular basis. In view of this, fresh applications are being invited for filling up the post of Assistant Professors on regular basis. Therefore, all candidates who had applied earlier in response to above advertisements of MAIDS will have to apply afresh in case they intend to be considered for the post of Assistant Professor, in order to update their profile. No further action is being taken on the applications received earlier. The candidates who had applied earlier will be given benefit of fee deposited by them.

- 4. **Age Limit:** 45 years to be reckoned with reference to last date of submission of application i.e. 21.1.2022. Relaxation to SC/ST/OBC will be allowed as per rules.

- 4.1.1.1.The candidates who had applied in response to our advertisement dated 10.12.2018, whose last date of receipt was 15.1.2019, the age limit will be reckoned with reference to last date of receipt i.e. 15.1.2019 provided the candidate fulfils the eligibility criteria of 04 years Post PG Teaching Experience, age, qualification etc. as on 15.1.2019. List of candidates who had applied in response to advertisement dated 10.12.2018 is attached herewith as Annexure-I.
- 4.1.2. The candidates who had applied in response to advertisement dated 10.12.2018 shall mention their Serial number as given in Annexure-I against Col.No.1A. of the prescribed application form.
- 4.1.3. Those candidates who are not having 04 years Post PG Teaching Experience as on 15.1.2019 in their own interest, they are advised to apply fresh, submit fee of Rs.1000/- or 500/- and their eligibility w.r.t. age, qualification, experience etc. will be reckoned w.e.f. 21.1.2022 as they are not eligible to be considered against the advertisement dated 10.12.2018.

- 4.2.1 The candidates who had applied in response to our advertisement dated 20.12.2019, whose last date of receipt was 31.1.2020, the age limit will be reckoned with reference to last date of receipt i.e. 31.1.2020 provided the candidate fulfils the eligibility criteria of 04 years Post PG Teaching Experience, age, qualification etc. as on 31.1.2020. List of candidates who had applied in response to advertisement dated 20.12.2019 is attached herewith as Annexure-II.
- 4.2.2 The candidates who had applied in response to advertisement dated 20.12.2019 shall mention their Serial number as given in Annexure-II against Col.No.1A of the prescribed application form.

4.2.3 Those candidates who are not having 04 years Post PG Teaching Experience as on 31.1.2020 in their own interest, they are advised to apply fresh, submit fee of Rs.1000/or 500/- and their eligibility w.r.t. age, qualification, experience etc. will be reckoned w.e.f. 21.1.2022 as they are not eligible to be considered against the advertisement dated 20.12.2019.

(For candidates who had not applied in response to Advertisement dated 10.12.2018 & dated 20.12.2019 – Para-4.2.4)

- 4.2.4. The candidates who had **not applied** earlier in response to our advertisement dated 10.12.2018 & dated 20.12.2019 shall not mention any Serial Number against Col.No.1A of the prescribed Application Form as no serial number has ben provided to them so far.
- 5. **Fee Payable:** Rs.1000/- for General/OBC candidates and Rs.500/- for SC/ST/PH candidates. The fee should be paid in the form of Demand Draft issued in favour of **Director-Principal, MAIDS**, *payable at New Delhi*. Candidates before paying the fee should ensure that they are eligible in all respects as per the Advertisement Notice and under no circumstances, fee once paid will be refunded, even if the application is rejected.

5.2. Note for Fee for candidates who had applied earlier:-

- 5.2.1 The candidates who had applied in response to our advertisements dated 10.12.2018 and dated 20.12.2019, are not required to deposit fresh demand draft provided the candidate fulfils the eligibility criteria of 04 years Post PG Teaching Experience, age, qualification etc. as on 15.1.2019 & 31.1.2020 respectively. All such candidates who had applied in response to advertisements dated 10.12.2018 and dated 20.12.2019 and are eligible w.r.t. age, qualification, experience shall mention their Serial number as given in Annexure-I & II against Col.No.1A of the prescribed Application Form. If no serial number is provided then candidate shall have to deposit fee afresh or else the application form will summarily be rejected.
- 5.2.2 Those candidates who are not having 04 years Post PG Teaching Experience on last date of receipt of application i.e. as on 15.1.2019 & 31.1.2020 respectively, in their own interest, they are advised to apply fresh, submit fee of Rs.1000/- or 500/- and their eligibility w.r.t. age, qualification, experience etc. will be reckoned w.e.f. 21.1.2022 as they are not eligible to be considered against the advertisements dated 10.12.2018 and 20.12.2019.
- 6. <u>Mode of Selection</u>: The selection will be made through written screening test which would be qualifying only, followed by interview (Only those candidates who qualify the written screening test, will be called for interview) (QUALIFYING MARKS FOR WRITTEN TEST FOR GENERAL CANDIATES 50% AND OBC CANDIATES 45%). However, out of the maximum number of qualified candidates in written screening test who shall be called for interview shall not be more than 3 times the number of vacancies.

- 7. The decision of the selection committee will be final in this regard.
- 8. <u>How to Apply</u>: The application form can be downloaded from the MAIDS website i.e. <u>www.maids.ac.in</u>. Complete application in the prescribed format alongwith all relevant self attested documents and fee must reach on or before 21.01.2022 upto 4.00 P.M. in an envelope super-scribed in bold letters "Application for recruitment of to the post of Assistant Professor———" (name of speciality to be filled by candidate) directly or by post, addressed to "The Director-Principal, Room No.116, 1st Floor of Maulana Azad Institute of Dental Sciences, Bahadur Shah Zafar Marg, New Delhi-110002". MAIDS shall not be responsible for delay in receipt of application by postal authorities or by the Courier Company. Therefore, candidate should plan accordingly.

9. Documents to be attached:

Self attested copies of certificates in support of age, caste, qualification, experience, state council registration and two passport size photographs, Demand Draft etc. (Research papers need not be added with application)

10. Important Note:

- 10.1 <u>OBC certificate should be issued from Govt. of NCT of Delhi as "OBC (Delhi)".</u> OBC Certificate issued from any state other than Delhi or certificate issued from Govt. NCT of Delhi but on behalf of any other state will not be considered. General are not eligible to apply against Reserve category post.
- 10.2. Candidate shall be appointed as & when the vacancy actually arises. Post of Assistant Professor (Dental Anatomy) and Assistant Professor (Forensic Odontology) are for Phase- II project of MAIDS and will be filled on taking over of Phase II project by MAIDS.
- 10.3 No TA/DA will be paid for written test and interview.
- 11. On the directions of Health and Family Welfare Department (H&FW) GNCTD reservation has been worked out as per DoPT OM No.F36012/2/96-Estt.(Res) dated 2.7.1997 and OM No.36039/1/2019-Estt.(Res) dated 31.1.2019 and reservation has been mentioned against each post.
