- 1. All the posts carry usual allowances as admissible to Central Government Employees of similar status at Gorakhpur, Uttar Pradesh.
- 2. <u>Application Process: -</u> The aspiring applicants satisfying the eligibility criteria in all respect can submit their application only through <u>Offline</u> mode. Application is made available on AIIMS, Gorakhpur official website i.e. <a href="http://www.aiimsgorakhpur.edu.in">http://www.aiimsgorakhpur.edu.in</a>. The applications in respect of above said posts along-with other relevant information will be available on the date of advertisement on Employment News/ Rojgar Samachar. The last date of submission of applications will be 02.05.2022.
- 3. The applicants applying advertisement should check their eligibility for the post applied for. They must be fulfilling eligibility criteria as on the closing date of applications failing which their application will be rejected.
- 4. In case a candidate wishes to apply for more than one post, he/she is required to fill the form separately for each post.
- 5. The candidates have to send signed copy of Offline application form along with self-attested copies of certificates/documents in support of fulfilling the essential criteria of age, educational qualification, teaching/research experiences etc. In support of their candidature. ### 10. Maximum Age Limit: -

Professor/Additional Professor: - Not exceeding 58 (Fifty-Eight) years as on the last date of the receipt of the application.

Associate Professor/ Assistant Professor: - Not exceeding 50 (Fifty) years as on the last date of the receipt of the application.

Age relaxation to other categories will also be applicable as per the DoPT instructions. However, age relaxation will be regulated as per the DoPT instructions.

- 11. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/PwBD/EWS will be considered subjected to Caste/Disability/EWS Certificate issued by the appropriate/Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.
- 12. Applicants applying for the posts reserved for OBC must obtain certificate of OBC (non- creamy layer) in the prescribed form issued by Competent Authority. The certificate should be of the current financial year, in accordance with instructions issued by the Government of India in this respect from time to time. Applicants should ascertain that they belong to the reserved categories (caste) enlisted in the Central List for the Other Backward Classes. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s). Similarly, EWS certificate will be strictly as per the instructions of the Government of India.
- 13. Only such persons would be eligible for reservation under PwBD quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format.
- 14. The candidates are to satisfy all eligibility criteria before Offline application. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.
- 15. Qualifications and Experience: Qualifications and experience as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee with prior approval of the Competent Authority. The experience will be counted as on last date of submission of Offline application. The equivalent qualification will be decided by the Competent Authority of AIIMS, Gorakhpur and his/her decision in this regard will be the final.

- 16. Short Listing/Methods of the Selection: The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on details of the candidate, the Screening Committee may short- list candidates for interview. If required there may be Screening test to shortlist candidates for interview in case large number of candidates apply for a post or posts. Candidates called for interview will have to produce all relevant original documents as proof of details furnished in their application at the time of interview. They may also be asked to submit an affidavit/declaration as decided by AIIMS, Gorakhpur at time of Interview. The methodology of selection will be decided by the Selection Committee as deemed fit besides any other matter related to the selection process.
- 17. **Site of Interview:** Interviews will be held at AIIMS Gorakhpur or any other place as decided by the Executive Director, AIIMS, Gorakhpur. No TA/DA will be paid for appearing in the interview.

### 18. <u>APPLICATION FEES</u>:

- a) General (UR)/ OBC /EWS Candidates: Rs.3,000/- (Rupees Three Thousand Only).
- b) \*SC/ST/ Women/Persons with Benchmark Disabilities Candidates Rs.200/- (Rupees Two Hundred Only).
- c) The candidates have to pay prescribed application fees through **Demand Draft in favour of AIIMS**, **Gorakhpur Payable at Gorakhpur**
- d) Application fee once remitted shall not be refunded under any circumstances.
- 19. The applicants already in Government service shall have to produce Relieving Certificate from their present employer before joining the Institute.
- 20. The applicants already in Government service (including AIIMS Employees) shall have to produce No Objection Certificate from their present employer at the time of Interview or as per the instructions issued from time to time. However, they have to take prior permission from their employer while applying for the post. No candidate will be allowed to appear in the interview without NOC from his/her employer.
- 21. **Decision of AIIMS, Gorakhpur is final:** The decision of AIIMS, Gorakhpur in all matters related to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, methodologies for the selection and any corrigendum or revision of the advertisement or any other information regarding this recruitment will be posted on the official website of AIIMS, Gorakhpur only in due course.
